**1. Present Financial Status by the Treasurer**

Sri K. Durga Nageswara Rao, Treasurer presented the accounts for the period from 13.07.2024 to 13.10.2024. As on date, the financial strength of the Association is Rs. 14,72,613. Details are presented below:

**2. Preparation/ issue of Membership cards by Sri. S.S.K. Tulasi Rao, OS.**

Sri. Tulasi Rao informed that a total of 103 Membership cards were prepared in 3 batches from 2017 to 2023 and 82 cards were issued. The remaining 21 cards could not be issued since the concerned members were absent in the subsequent Annual Meets held after the cards were made. Details of new cards to be prepared will be given to Sri Tulasi Rao by Sri. E. Madhava Rao and Sri. K. Durga Nageswara Rao. The cards will be prepared by 31.12.2024.

**3. Bifurcation of the list of 943 members into two parts by Membership Committee (Paid Members and Un-paid Members).**

In the 2<sup>nd</sup> ECM held on 14.07.2024, Sri. Rangayyappa Rao requested Sri Maruthi Prasad to bifurcate the list of 943 members into two parts; part 1 containing details of 153 paid members and part 2 containing details of 790 members and make a digital book by combining these two parts.

**4. Cost break-up for “New facilities and Repairs at GPV” by Dr. N.V. Rao**

The Principal, GPV sent a list of requirements on 14.07.2024. The Secretary requested the Principal on 21.08.2024 for details of each work and its cost; so far no reply has been received from the Principal. Sri VV Krishna Mohan will coordinate with the Principal for the details by 31.10.2024.

### **5. Joining of one lady member into EC - Nandam Srinivas**

Dr. Nandam Srinivas contacted a few youngsters of GPV and Mrs. Satyavani, Metallurgy lecturer at GPV to recommend one lady member. She gave the contact number of Mrs. Divya working in Hyderabad. Details are yet to be received from Mrs. Divya and the youngsters.

### **6. Status of preparation of “Proceedings of 21<sup>st</sup> Annual Meet held on 07.01.2024” by the Secretary**

The secretary prepared the draft Proceedings (172 pages) and discussed them with Prof. Murty. After clearance of the draft, 4 copies of the final version were made and issued as per the details given below. ### **7. Industrial visit to mobilize funds**

Details of the industrialists are yet to be finalized by Sri G. Ramesh Kumar. Dates for industrial visits will be finalized after receiving the details from the Principal GPV as mentioned in point 4 above.

### **8. Procurement of land to build our Association office**

Sri SLN Sastry requested the Director of IIIT to give 300 Sq. Yds land on lease for the construction of the GPVAAH Office building for which the Director did not agree. Sri Sastry discussed the issue with Professor Murty along with Dr. Venkateswara Rao in Sept. 2024. The subject was also discussed in detail in the present meeting, and it was decided not to purchase any land/ Building and to continue the meetings in IIIT Guest House.

### **9. Introducing welfare schemes for poor members of GPVAAH**

This point was well discussed in previously held two Annual Meets. All the GB members were requested to identify and recommend poor members (Alumni of GPVVH only) for extending help from our Association. All the EC members were also requested to identify poor members through circulations in other WhatsApp groups of GPV. Till now no recommendation has been received by the Association. In view of this, the point is closed.

### **10. All new EC members to take Life Membership in one month by paying Rs.10,000 or more**

As per the decision taken in one of the EC meetings in 2015 to strengthen the financial condition of the Association, all the EC members have been taking Life Membership till now by paying an appropriate Membership fee. In the 1<sup>st</sup> ECM held on 07.04.2024, 7 new members were taken into the EC and two of them are already Life Members. Out of the 5 remaining members, Sri G. Lakshmana Rao asked for the rule position to pay the Life Membership fee. When clarified by the Secretary that there is no rule in the Bye-Laws and it can be incorporated in the next revision, the Chairman stated that it is not mandatory to become a Life Member to work in the EC.

## 11. Discussion on amendments to Bye-Laws - already done/approved by GB

Secretary presented that the Bye Laws were amended in 2018, 2023 & 2024 and approved by the GB. These amendments were documented in the “Annual Meet Proceedings-2024” and the details are presented below:

**In 2018:** The following points/ amendments were proposed and approved in the 17<sup>th</sup> Annual Meet of GPVAAH held at IIIT, Gachibowli on 7-01-2018.

- If any EC/MC Member is absent for the EC/MC meetings consecutively for more than two times with/without leave or if he/she is not completing the assigned work, the EC/MC Member can be considered for termination by the EC.
- The following Membership fee for different categories of Memberships was decided in 2015 and has been followed since then. However, GB approval was not taken in the GB meetings held in 2016 and 2017 and hence put up for GB approval in 2018.

**In 2023:** The following points were put up to GB in the 20<sup>th</sup> Annual Meet of GPVAAH held at IIT, Kandi, Hyderabad on 29.01.2023 and the GB approved the same:

- Formation of Advisory Committee (AC)
  - Revision of Membership Fees
1. Formation of Advisory Committee (AC): The Advisory Committee was formed on 14.07.2020 with the following senior members:

The terms of reference for the AC are:

- i) The AC will meet once or twice in a year and review the activities being conducted by the EC.
- ii) The AC will discuss and advise the EC about the welfare/ activities to be taken up at GPV.
- iii) All the amendments to the byelaws will be cleared by AC before putting up to GB.
- iv) The Chairman may co-opt any member of GPVAAH on a need basis.

The GB approved the Advisory Committee with the above terms of reference.

### 2. Revision of Membership Fees:

The prevailing fee for different categories of membership was almost 8 years old. Therefore, it was proposed to revise the Memberships fee as under:

The GB approved the above revision.

**In 2024:** Sri K. Rangayyappa Rao prepared GPVAAH Organizational Charts which re-define the responsibilities of all EC and AC members. After detailed discussions in the EC meetings, these charts were put up to GB for final approval and implementation; the GB approved the same. These charts are enclosed as **Annexure-1**.

## **12. Registration of amended Byelaws**

GPVAAH was registered in 2017 with the Registrar of Societies, Ranga Reddy Dt. located in Balanagar. The above amendments are also to be registered with the same office. The following members were identified by the EC to find out the procedure and to complete the registration of amended Byelaws:

3. Sri NNR. Pavan Babu, EC Member

## **13. Any member having 15 years of Service/15 years of Membership and paid a total donation of ₹ 50,000 or above may be considered as eligible for Chief Patron**

As per byelaw 4.5, any Member who is generous to pay Rs.1,00,000 or more will be given the title of Chief Patron of GPVAAH. Sri Rangayyappa Rao informed that there are few members in our AC who have been working for the Association since its inception (more than 24 years) and proposed that “any member with 15 years of service to the Association + a donation of Rs.50,000 or more” is to be considered as Chief Patron. The EC accepted the proposal and this needs to be ratified in the next GB meeting.

Sri K Rangayyappa Rao and Sri M Anjaneya Raju are founder members and paid donation amounts of Rs.71,101 and Rs.61,100 respectively. Therefore, these two members are hence forth considered as Chief Patrons. Revised list of Chief Patrons is enclosed as **Annexure-2**.

## **14. Selection of the chief guest for the AGM 2025.**

It is a usual practice to invite our Alumnus, who is a Govt servant holding a higher position or an Industrialist in alternate years as a Chief Guest. In the previous Annual Meet-2024, Sri D. Sreedhar, Dy. Chief Executive of NFC was invited as Chief Guest. Therefore, for the next Annual Meet-2025, an Industrialist (not attended as a Chief Guest in the previous Annual Meets) is to be invited. Since the EC does not have enough data on Industrialists, it was decided to get the details of Industrialists by circulating a format in WhatsApp groups. The format will be made by the Secretary and Sri Rangayyappa Rao.

## 15. Any other points with permission of the Chair

- i) Merit Awards - 2025 amount is to be collected from the Sponsors by the Treasurer before the next ECM (4<sup>th</sup>) to be held on 08.12.2024 (Sunday).
- ii) 5<sup>th</sup> ECM will be held on 29.12.2024 (Sunday).
- iii) The next Annual Meet (GBM) will be held at IIT, Hyderabad on 05-01-2025 (Sunday).
- iv) Sri SSK Tulasi Rao, OS was shifted from EC to AC as he is a senior member (more than 75 years old). Sri A. Suresh, JS-2 is chosen as OS. As a result, Dr. N. Srinivasa Rao, JS-3 will become JS-2. However, Sri Tulasi Rao will continue to do the Membership Cards work till the next GBM.
- v) Sri K. Veerabhadra Rao, Vice President, EC, was moved from EC to AC due to his seniority in the 1<sup>st</sup> ACM. But, he is interested to work in EC. Therefore, in the present meeting, it was decided to shift him from AC to EC as Co-opted member.
- vi) In the 1<sup>st</sup> ACM Sri MNV Viswanath, EC Member was dropped from EC as he is a member of several other professional bodies and is not able to take much load of GPVAAH. However, he was requested to attend EC meetings as a Special Invitee. In the present meeting, it is decided to take him to EC as Co-opted member.
- vii) Sri K. Rangayyappa Rao was attending EC meetings as a Convener. In the 1<sup>st</sup> ACM, he was dropped from EC by the Vice-Chairman as there was no need for a Convener for the EC. But, Sri Rangayyappa Rao has been attending the EC meetings as a Special Invitee. For this reason, in the present meeting, it was decided to take him to EC as Co-opted member.
- viii) In view of the above changes, the revised lists of AC Members and EC Members are prepared and enclosed as **Annexure-3** and **Annexure-4**, respectively.
- ix) Identification of new/younger Members: In our Association, most of the members are senior citizens and younger people are very less. To encourage the younger generation, Prof. Murty is interested in meeting our younger Alumni working in DMRL, Midhani and NFC. In this connection, lists of our Alumni working in DMRL, Midhani and NFC are to be prepared and handed over to Prof. Murty in one month time (by 13th Nov 2024) by Dr. Nandam Srinivas, Sri KDN Rao and Sri MNV Viswanath respectively.
